Dr. Eleanor Cheung, the Chairman, started the meeting at 7:30pm.

1. Confirmation of Minutes of Last Meeting

Minutes of the last AGM held on 25 August 2017, Friday, were taken as read. It was proposed by Mr. Sunny Chan, seconded by Dr. Aaron Chiang and unanimously agreed by all present that the minutes be confirmed as a true record.

2. Chairman's Report

The Chairman presented the report which covered the free talks for TID, observation on training of eco-historical tour guide, career talk for high school students, visits to organizations, sharing session on HKQF for HRM sector, Certified Trainer (CT) Scheme and Mentoring Programmes for Lingnan University and Tsing Yi IVE, and other cultural and recreational activities.

To conclude her report, the Chairman thanked members of the Executive Committee for their efforts and valuable time put forward during the year. It was remarked that gratitude was presented to the Chairman's leadership and ex-General Manager's contributions. It was proposed by Ms. Angie Yu, seconded by Dr. Denny Chow and unanimously agreed by all present to accept the Chairman's Report.

3. To consider and amend some of the provisions of the Regulations and By-Laws of ITP

The amended Regulations and By-Laws were shown in Appendix I. After lengthy deliberation, all the amendments were reviewed and approved. The acceptance of the amendments was proposed by Mr. Sunny Chan, seconded by Prof. Alfred Ho and unanimously agreed by all present.

4. <u>To approve the Financial Statements for the year ending 30th June 2018</u>

Dr. Aaron Chiang, the Hon. Treasurer reported that the financial statements of the year had been audited by Ms. Evelyn Cheung, MITP and were found in order. He highlighted that the Income and Expenditure Statement, showed that there was a deficit of HK\$240 for the year and in the Balance Sheet, HK\$17,114.13 at bank was recorded. The

financial status was stable. The acceptance of the financial statements for the year ending 30th June 2018 was initiated by Dr. Eleanor Cheung, seconded by Mr. Richard Lui and was unanimously agreed by all present.
